1: Product Details

1.1 Product Colours

All of our coloured cords are factory dyed in batches and therefore slight colour variations may occur.

1.2 Measurements

2: Orders

2.1 Availability

We will automatically send you an email to confirm your order. For this reason you must provide us with a valid email address.

2.3 Errors When Ordering

You can correct/change your order up until the point you click "submit". If your order has already been dispatched you will have to adhere to our returns policy.
